Amended Articles of Incorporation

of

PHILIPPINES RECORDED MUSIC RIGHTS INC.

KNOWN ALL PERSONS BY THESE PRESENTS:

The undersigned incorporators, all of legal age, have voluntarily agreed to form a non-stock and non-profit corporation under the laws of the Republic of the Philippines and certify the following:

FIRST:

That the name of the said corporation shall be

"PHILIPPINES RECORDED MUSIC RIGHTS INC."

SECOND: That the purposes for which such corporation is formed are:

- (a) To manage in the Philippines rights for the collective benefit of domestic and international performers and producers of recorded music the corporation represents in a fair, transparent, effective and non-discriminatory manner by effectively collecting remuneration and/or license fees for the use of recorded music, taking enforcement actions with respect to the rights it manages in its own name, and distributing the collected revenues to performers and producers of recorded music.
- (b) To obtain authorization from performers and producers of recorded music either directly, through their representatives, or through bi-lateral agreements with other collective management organizations to grant licenses and collect fees, and remuneration for the use of their recordings in indirect or direct public performance, radio and television broadcasting, re-broadcasting, cable retransmission, or other uses of recorded music as the corporation may from time to time be authorized to manage within the scope determined by its members;
- (c) To develop tariffs for the use of rights of the performers and producers of recorded music that the corporation represents that are adequate in relation to the economic value of the use of the rights in trade and the benefits to the users from the services provided by the corporation, as well as negotiate and agree with said users on the terms and conditions of such use;
- (d) To make applications to the court or other competent authority in respect of the exercise and/or enforcement of the rights the corporation manages, and to defend or otherwise participate in any other relevant proceedings

to the extent necessary to effectively carry out the rights management services;

- (e) To promote reforms in the law with respect to copyrights and related rights and ratification of respective international conventions or treaties.
- (f) To promote and foster by all lawful means the common interests of performers and producers of recorded music with respect to the collective management of their rights;
- (g) To the extent permitted by law, to acquire, own, hold, sell, convey, lease, lot, mortgage, or otherwise deal with such property, real, personal and mixed as may be necessary, advantages or convenient in the conduct of its operations and within the framework of adopted policies;
- (h) To borrow or raise money from not more than nineteen (19) members, including its members, for any of the purposes or objects of the corporation, and in pursuance thereof, to make, accept, endorse and issue any instruments and evidences of indebtedness of whatsoever nature and to execute and pledge, mortgage, deed of trust, or issue debentures, bonds, letters of hypothecation, or liens or obligations of the corporation, either at par, premium, or discount, secured by all or any part of the undertakings, revenues, rights and properties of the corporation, and to exchange or vary from time to time any such security.
- (i) To enter into agreements with other similar societies, associations or other organization in foreign countries providing for the reciprocal protection of the rights of the members of each society, association or other organization; and
- (j) To do any and all other acts and things and to exercise any and all powers which may be necessary or convenient in carrying out any of the purposes of the corporation or in protecting or furthering its interests or the interests of its members.

The term "members", as hereinabove used, is deemed to comprise performers and producers of recorded music who meet the separate eligibility criteria and who directly and indirectly entrust the management of their recorded performances and sound and/or video recordings to the corporation.

THIRD. That the principal office of the corporation is located at Suite 2802 Discovery Center, 25 ADB Avenue, Ortigas Center, Brgy. San Antonio, Pasig City 1605. (As amended on 03 March 2021)

FOURTH. That the corporation shall have perpetual existence.

SEVENTH. That the corporation shall be a non-stock and non-profit corporation and shall be financed and maintained by means of membership dues, fees, and deductions from the collected sums to cover the appropriate costs of managing the rights of represented performers and producers of recorded music, and fines and forfeitures as the Board of Trustees may provide from time to time. It shall have no shares of capital stock and no part of the properties or net income of the corporation shall inure to the benefit of any of its members, trustees, officers, organizer or any individual person. All members of the Board of Trustees of the corporation shall not receive compensation or remuneration for their service to the corporation.

EIGHT. That in the event of, or upon the legal dissolution of the corporation, all of its assets, after paying its debts and liabilities, shall be distributed amongst the members of the corporation as at the time of such winding up or dissolution or as the case might be shall be distributed by a competent court in special manner as in judgment of said court shall best accomplish the general purpose of which the dissolved organization was organized.

NINTH. The level of administrative expenses shall be reasonable in relation to the services provided by the corporation to performers and producers of recorded music and shall not exceed the justified and documented costs incurred by the corporation in managing the rights, and in any event shall not exceed 25% of its total revenue, during the taxable year without the approval of the Board of Trustees.

TENTH. That Christian Collas Monsod III has been elected by the members as Treasurer of the corporation to act as such until after the successor is duly elected and qualified in accordance with the By-laws that as Treasurer, authority has been given to receive in the name and for the benefit of the corporation, all contributions or donations paid or given by the members.

ELEVENTH. That the incorporators undertake to change the name of the corporation immediately upon receipt of notice from the Commission that another corporation, partnership, or person has acquired a prior right to the use of such name, that the name has been declared not distinguishable from a name already registered or reserved for the use of another corporation, or that it is contrary to law, public morals, good customs or public policy.


